RESOLUTION IN HONOR OF SUPREME KNIGHT CARL A. ANDERSON

WHEREAS, As Supreme Knight of the Knights of Columbus since 2000, Carl Anderson was the chief executive officer and chairman of the board of the world's largest Catholic fraternal benefit society, with over 2 million members worldwide in 2020.

WHEREAS, The Knights of Columbus was founded in 1882 in New Haven, Connecticut by the Venerable Father Michael McGivney to strengthen Catholic men in their faith and to assist the widows and orphans of deceased members. It has over 15,000 councils across the United States, Canada, Mexico and the Philippines; and Mr. Anderson has overseen recent expansions into Poland, Ukraine, Lithuania, France and South Korea, as well as re-activation in Cuba. Under his leadership, the Knights provided \$185 million directly to charity and contributed more than 76 million hours of volunteer service in 2018.

WHEREAS, Among his charitable initiatives are the establishment of the 2001 Heroes Fund to provide more than \$1 million in immediate aid to the families of first-responders killed on 9/11, the Pacem in Terris Fund to provide scholarships to Christian schoolchildren throughout the Holy Land, more than \$8 million in direct assistance following Hurricane Katrina, more than \$1 million to provide prostetic legs to Haitian children suffering amputations following the 2010 earthquake there; \$12 million to assist Christian and other religious refugees.

WHEREAS, Mr. Anderson had overseen the strong growth of the organization's insurance program and financial resources. Since 2000, its life insurance in force has grown from \$40 billion to more than \$104 billion. The Knights of Columbus is among the most highly rated life insurers in North America, having received the top rating from A.M. Best (A++, Superior) for 41 consecutive years and the highest rating possible for a U.S.-based insurance company from Standard and Poor's (AA+).

WHEREAS, due to Mr. Anderson's high moral standards, the Knights of Columbus received certification as a "2016 World's Most Ethical Company" from Ethisphere Institute. Mr. Anderson was recognized by that organization as one of the "100 Most Influential People in Business Ethics." London's *The Tablet* has described him as "one of the most influential Catholics in the world." He has been described in *National Review* as "the epitome of Catholic leadership" and listed by *Newsmax* as among the top 40 Christian leaders in America.

WHEREAS, during his tenure, the Knights' assets under management have increased from \$8.5 billion in 2000 to more than \$22 billion. In February 2015, Knights of Columbus Asset Advisors LLC was launched to offer investment services to Catholic dioceses, institutions and religious communities based on the investment strategies and philosophy successfully utilized by the Knights for its own portfolio. It now offers six Catholic ethically screened mutual funds.

WHEREAS, Mr. Anderson has served on five pontifical councils, including the councils for Social Communications, for Justice and Peace, for the Family, for the Laity, and the Academy for Life. He was also named to the board of superintendence of the Institute for the Works of Religion (popularly known as the Vatican Bank) — where he played an integral role promoting transparency and bringing the Institute into alignment with international banking standards and best practices. He has served as an auditor at four world synod of bishops held at the Vatican.

WHEREAS, under his leadership, the Knights of Columbus established the Saint John Paul II National Shrine in Washington, D.C. In 2014, the U.S. Conference of Catholic Bishops designated the Shrine a national shrine as it opened a world-class permanent exhibit on the life of St. John Paul II. In 2016, the Shrine dedicated the Redeemer of Man church and the Luminous Mysteries chapel. Mr. Anderson serves as the Shrine's director and chairman of the board.

WHEREAS, Prior to becoming Supreme Knight, Mr. Anderson led a distinguished career as a public servant and educator. He worked for a number of years in the White House — including special assistant to the president and acting director of the White House Office of Public Liaison for President Ronald Reagan. He also served for a decade as a member of the U.S. Commission on Civil Rights.

WHEREAS, He taught family law at the Pontifical John Paul II Institute for Studies on Marriage and Family at the Pontifical Lateran University in Rome and was founding vice president and first dean of the Washington, D.C., campus of this graduate school of theology now located at The Catholic University of America. He has addressed numerous conferences and academic meetings in countries including Israel, Cuba, Chile, Mexico, the Philippines, Korea, Poland, France, Germany, Ireland, Italy, Spain, Belgium and Vatican City.

WHEREAS, He is the author of books that, in total, have been translated into eight languages, including the New York Times bestseller A Civilization of Love: What Every Catholic Can Do to Transform the World, Our Lady of Guadalupe: Mother of the Civilization of Love (with Eduardo Chavez), Called to Love: Approaching John Paul II's Theology of the Body (with Jose Granados), and Beyond a House Divided: The Moral Consensus Ignored by Washington, Wall Street, and the Media.

WHEREAS, He is an Emmy-awarding winning executive producer of the documentary film, *Liberating a Continent: John Paul II and the Fall of Communism* narrated by Jim Caviezel (2016) and executive producer of the feature film, *For Greater Glory* featuring Peter O'Toole and Andy Garcia (2012).

WHEREAS, He has appeared on NBC's *Today Show*, ABC's *World News Tonight*, CNN, FOX News and Vatican Radio with opinion pieces published in *The Washington Post, The Washington Times, The Wall Street Journal, The Chicago Tribune, The Hill, Roll Call, Real Clear Religion, National Review* and *L'Osservatore Romano, among others*.

WHEREAS, Mr. Anderson has served on numerous boards including that of The Catholic University of America, the National Catholic Educational Association, and the Basilica of the National Shrine of the Immaculate Conception. He also serves as a consultor to the U. S. Conference of Catholic Bishops committees on the family, on marriage, on religious liberty and on pro-life.

WHEREAS, in 2016, Mr. Anderson was awarded the Order of Merit by the President of Poland.

WHEREAS, He has received numerous awards including the Path to Peace and Servitor Pacis awards of the Path to Peace Foundation (Permanent Observer Mission of the Holy See to the United Nations) and the University of Notre Dame Center for Ethics and Culture's Evangelium Vitae Medal.

WHEREAS, He is a Knight Grand Cross of the Order of St. Gregory the Great, Knight Grand Cross of the Order of Pope St. Sylvester and Knight Grand Cross with Gold Palm of the Order of the Holy Sepulchre of Jerusalem. He has been awarded eight honorary doctoral degrees by institutions of higher learning in the United States and Europe.

WHEREAS, Mr. Anderson holds degrees in philosophy from Seattle University and in law from the University of Denver. He is a member of the bar of the District of Columbia and is admitted to practice law before the U.S. Supreme Court.

WHEREAS, He and his wife, Dorian, are the parents of five children and eight grandchildren.

WHEREAS, Patrick E. Kelly is the 14th Supreme Knight of the Knights of Columbus. Taking office on March 1, 2021, he serves as the chief executive officer and chairman of the board of the world's largest Catholic fraternal service organization, with more than 2 million members.

WHEREAS, Mr. Kelly's has had a distinguished career in the Knights of Columbus, the military and public service. For more than 25 years, he has a demonstrated track record of service to Church and country, which serves him well in advancing the Knights' mission of Charity, Unity, Fraternity, and Patriotism.

WHEREAS, Mr. Kelly has served as Deputy Supreme Knight since 2017. Prior to that, he served as Vice President for Public Policy for 11 years, spearheading the Knights' interaction with the White House, Congress and federal agencies. He has also served as State Deputy in the District of Columbia. As a longtime executive and fraternal leader of the Knights of Columbus, he has consistently strengthened its record of charity, advocacy, insurance, investment, and membership growth.

WHEREAS, Mr. Kelly served as the first executive director of the Saint John Paul II National Shrine in Washington, D.C., and oversaw the renewal of the facility after its purchase by the Knights in 2011. During his tenure, the shrine became a leading pilgrimage site and a source of education and inspiration for Catholics throughout the United States and the world.

WHEREAS, prior to his leadership roles in the Knights, Mr. Kelly pursued a lengthy career of public service. Most notably, he was Senior Advisor to the Ambassador-at-Large for International Religious Freedom at the State Department from 2005 to 2006. His

responsibilities included serving as the Department's principal liaison with the Holy See and assisting with the formulation of U.S. foreign policy on religious freedom worldwide. He led U.S. delegations to the World Summit on Islamic-Christian dialogue (2005), the UN conference on interfaith cooperation (2005), and annual Sant'Egidio conferences. He has also held advisory roles on the House Intelligence Committee and the Department of Justice, where he specialized in counterterrorism and national security.

WHEREAS, Mr. Kelly served in the United States Navy for 24 years, on land and sea and on active duty and reserve status. As a Judge Advocate General, he specialized in international and operational law and served as the Commanding Officer of the international law unit at the U.S. Naval War College. He served on the staff of the Deputy Chief of Naval Operations and aboard the USS *Guam* as the Staff Judge Advocate for Amphibious Squadron Two. His personal awards include three Navy Achievement Medals, five Navy Commendation Medals and the Meritorious Service Medal. He retired from the JAG Corps Reserve in 2016.

WHEREAS, Mr. Kelly has served as consultant to three committees of the U.S. Conference of Catholic Bishops (USCCB) for more than a decade: The Committee on Pro life Activities, the Committee on Religious Liberty, and the Subcommittee for the Promotion and Defense of Marriage.

WHEREAS, Mr. Kelly has been the Chairman of the Board of Directors of the March for Life since 2012. Under his leadership, the March for Life has become one of the most effective pro-life organizations in the world. He has also been a member of the Board of Directors of the National Catholic Bioethics Center (NCBC) since 2013. He has helped guide the NCBC in its mission to promote respect for the dignity of each human being through an understanding of how the moral teachings of the Church apply in health care and the life sciences.

WHEREAS, Mr. Kelly holds a master's degree in theology from the Pontifical John Paul II Institute for Studies on Marriage and Family at The Catholic University of America, a law degree from Marquette University Law School and a bachelor's degree in economics from Marquette University, where he joined the Knights of Columbus in 1983.

WHEREAS, he and his wife, Vanessa, have three daughters, and live in Connecticut.
